SSS earns P28B in 2021; reported net loss due to new accounting standards

The Social Security System (SSS) registered earnings of P28 billion in 2021 from its operations, with contributions and investment income exceeding benefit payments and operating expenses.

In its 2021 unaudited financial statement, its cash inflows of P262 billion surpassed its cash outflows of P234 billion.

In the last six years, SSS recorded cumulative earnings of P202 billion, even with a record-breaking P1.1 trillion benefit payments and P254 billion loan releases to its members and pensioners.

SSS' adoption of the Philippine Financial Reporting Standards (PFRS) 4, which recognizes Social Benefit Liabilities (SBLs) and the Margin for Adverse Deviation (MfAD), resulted in an increase in policy reserves of P872 billion that contributed to the accounting net loss of nearly P844 billion for

"We want to clarify that the increase in policy reserves is not actual cash that went out of the fund in 2021. These are simply estimates of the required reserves to fund future benefit claims," SSS President and CEO Michael G. Regino said.

"We recognize these

future liabilities as early as now to be more transparent in managing the SSS fund and to create a clearer view of our longterm financial standing. We assure our stakeholders that this does not affect our current cash flows and we remain financially viable in terms of providing benefits to our members," he added.

Notably, the SSS' fund life is estimated to last until 2054. The estimated fund life of the social security institutions of other ASEAN countries such as Vietnam and Thailand are until 2027 and 2054, respectively, while the United States Social Security Administration fund is expected to last only until

Regino said that SSS is always open to dialogues with policymakers, which can be a platform to help the pension fund's stakeholders understand the current accounting standard it follows for the reporting of its financial performance. (PR)

DOH confirms 53 cases with 8 deaths due to leptospirosis in the region since start of the year

TACLOBAN CITY-The Department of Health (DOH) in Eastern Visayas has reported 53 cases of leptospirosis counting from the start of the year until

Of the 53 individuals who were afflicted by the disease, eight of them died, Jelyn Malibago, the regional information officer of the DOH, said on Wednesday (June 1).

"We expect more cases of leptospirosis especially since we are experiencing rainy season which results in flooding," she said.

Thus, the health official urged the public not to wade in flooded areas for them to avoid getting the bacteria caused mainly from the urine of animals like rodents.

Malibago also said that if one is to wade in floods, one should wear boots and gloves; drain potentially contaminated water; control rodents in the house by using traps or poison, and maintain cleanliness.

Of the 53 cases, 22 were from Leyte; 10 from Samar; seven each from Southern Leyte and Eastern Samar; Samar; seven from Southern Leyte; five from Northern Samar; and two from Biliran.

Meantime, the three deaths due to leptospirosis in Leyte were from Tacloban City, Abuyog, and Hilongos; the two deaths from Southern Leyte were from the towns of Padre Burgos and Hinunangan; the two deaths in Samar were from Basey and Catbalogan City; and the single death in Eastern Samar was from Maydolong town.

Among the symptoms of those who were infected of the leptospirosis include fever; headache; child; muscle and abdominal pain; and vomiting.

The leptospirosis bacteria enter the human body through cuts in the skin or through membranes of the eyes, nose, and mouth.

Last year, there were 25 leptospirosis cases in the region with eight deaths. (JOEY A. GABIETA)

DPWH-NSFDEO widens road at Brgy. San Agustin Mondragon along Catarman-Laoang Road section

CATARMAN, Northern Samar-the Department of Public Works and Highways (DPWH) Northern Samar First DEO has recently completed a widening project at Barangay San Agustin Mondragon along Catarman-Laoang section.

The P9.95 million project consists of a 600m-length road widening both sides, 3.35m width from 753+180 to 753+780, Brgy. San Agustin, Mondragon Northern Samar.

District Engineer Mario D. Villena said that the widening of the said portion was intended to offer a safer and a wider road network that will give



comfort to the travelling public especially since the area connects the towns of Catarman and Mondragon. It also serves as the main thoroughfare going to the pacific towns of Northern Samar.

The said project started last Febru21, 20, 22022 and was completed on April 25,2022, one month ahead of schedule.

In the wake of explosion incident in Basilan

Banac directed all police in EV to intensify secure measures to prevent any possible terror attacks

TACLOBAN CITY-The Philippine National Office here in the region said in a statement. has intensified its security measures in the wake of explosion incidents in Isabela City, Basilan last May 30 which resulted in the death of a civilian.

B/Gen. Bernard Banac has directed all unit commanders and chiefs of police in the region to initiate proactive measures to deter any hostile actions by lawless elements.

"Let us be more alert and cautious especially that these terrorists don't hesitate to create chaos anywhere they would please," the police regional director

"Let us all be vigilant in our respective areas of responsibility to prevent any terroristic attacks," Banac added.

Banac said that with all security measures are up in the region, a similar incident that hit Isabela could be avoided.

As part of the security measure, police stations are to conduct inspections to potential terrorist target areas like shopping malls, vital infrastructure, mass

DOH reports more than 200 new cases of dengue in EV compared to last week

TACLOBAN CITY -The number of dengue fever cases in the region has now reached 1,568, an increase of 216 from last week as reported by the Department of Health (DOH).

Based on the data of the DOH, except for the province of Northern Samar, all provinces in the region logged an increase of dengue fever cases this week compare to last week's re-

Leyte province has 613 dengue cases from its last week's 550 cases; Southern Leyte has 500 cases from the previous 413 cases; Samar, 174 cases from its 151 last week's cases; Eastern Samar, 117 from its previous cases of 108; 105 cases for Biliran from its last week's 70 cases.

Northern Samar has still 59 cases.

The DOH, speaking through its regional information officer Jelyn Malibago, added that deaths due to dengue fever now rose to six from last week's

The Department of Health renewed its call for the public to practice the 4S as the region is experiencing a surge of dengue fever cases. As of this week, the region has now 1,568 dengue fever cases. (Photo File)

The new recorded dengue deaths were from Ormoc City and are Jaro, both in Leyte; Maasin City and Padre Burgos in Southern Leyte; Taft in Eastern Samar, and Calbayog City in Samar.

The barangay with clustered cases now reached 36 from the 31 villages last week. Of this number of villages, 22 from Southern Leyte; five from Leyte; three each from Eastern Samar and Biliran; two from Samar; and one from Northern Samar.

With the increasing number of dengue cases in the region, Malibago urged the community to help the government in preventing the further spread of the virus in the community by

practicing the 4S strategy which includes search and destroy of mosquito breeding places; seek early consultation; self-protection method; and support fogging in areas with high cases of the

Malibago asked the local government units with clustered cases or those with more than two cases to implement fogging to avoid outbreaks.

Dengue is a fatal disease according to the health agency but can be prevented if measures are implemented to prevent mosquitos from having breeding grounds.

Symptoms of dengue cases include fever, vomiting, rashes, pain behind the eyes, muscles, joints, and

District Engineer Mario Villena disclosed that the repair and rehabilitation works of said bridges were prioritized to strengthen these structures and to mitigate the scouring on their foundations for the safety of the motorists and travelling pub-

Rehabilitation works were completed for the following bridges: rehabilitation and major repair of bridge, including slope/scour protection at Abutment A using Reinforced Concrete Revetment for Londres Bridge (P 959,961.56); construction of slope protection

sealing the existing road using bituminous asphalt on Abutment A, Abutment B, and Pier 3 for San Miguel Bridge (P973,401.84); rehabilitation and major repair of bridge including construction of reinforced concrete revetment at Abutment A and B, stone masonry, and concrete shoulder for Catarman Bridge (P961,077.09); rehabilitation and major repair of bridge which includes the construction of reinforced concrete revetment at Abutment B, painting, and an additional length of drain pipe for Taguibian Bridge (P964,011.09); and construction of reinforced concrete revetment at Abutment Painting and additional 1m long of drain pipes for Dizo Bridge (P960,172.43).



He was executed by the Spanish colonial government for the crime of rebellion after the Philippine Revolution broke out; it was inspired by his writings. Though he was not actively involved in its planning or conduct, he ultimately approved of its goals which eventually resulted in Philippine independence.

Rizal is widely considered one of the greatest heroes of the Philippines and has been recommended to be so honored by an officially empaneled National Heroes Committee. However, no law, executive order or proclamation has been enacted or issued officially proclaiming any Filipino historical figure as a national hero.[9] He wrote the novels Noli Me Tángere (1887) and El filibusterismo (1891), which together are taken as a national epic, in addition

U.S. Peace Corps holds training to strengthen biodiversity conservation in the Philippines

Manila-The U.S. Peace and GIS mapping. Corps recently held a biodiversity conservation training to help address biodiversity threats in Minalungao National Park in Nueva Ecija and Panaon Island in Southern Leyte.

The training, held in Laguna from May 11 to 19, brought together nearly 50 participants from Nueva Ecija University of Science and Technology, Southern Leyte State University, Nueva Ecija's Protected Area Management Board, and Panaon Island local government.

The training included specimen sampling and data collection at Taal Lake, Mt. Makiling, and Calatagan, and it also featured lectures from experts on state-of-the-art biodiversity assessment in terrestrial, marine, and inland aquatic environments

"The aim of this critical workshop was to support academe and government partners in working together to reduce threats to biodiversity in Minalungao National Park and Panaon Island," said U.S. Peace Corps Country Director Jenner Edelman.

While the Philippines is one of the most biodiverse countries in the world, it risks losing its significant biodiversity resources without better conservation efforts to address the growing population, increasing pollution, and the impacts of climate change.

Through this training, participants developed new skills for conducting biodiversity conservation research and were able to craft management plans to address biodiversity threats.

Funded by the United States Agency for Interna-

tional Development, the training was conducted by the University of the Philippines-Los Baños' School of Environmental Science and Management, which is recognized by the Commission on Higher Education as a Center of Excellence on Environmental Science.

The U.S. Peace Corps is the U.S. government's premier volunteer service organization. Over 9,300 American volunteers have served alongside host communities across the Philippines since it was founded in 1961. In the absence of American volunteers due to the pandemic, the U.S Peace Corps is collaborating with host country partners to meet the Philippines' most pressing development priorities, such as biodiversity conservation, through initiatives like this workshop.

DPWH completes flood control structure to protect Yolanda victims in Pagnamitan, Guiuan

BORONGAN CITY-Department of Public Works and Highways Eastern Samar District Engineering Office constructed flood control structure in Brgy. Pagnamitan, Guiuan, Eastern Samar to protect the lives and properties of the residents living along the area.

The flood control structure in Brgy. Pagnamitan has a length of 252 meters with a project cost amounting to P 29,643.037.78, funded under General Appropriations Acts 2020.

Gina Ugardo, a resident of Pagnamitan said that during the typhoon Yolanda, all houses were totally damaged by the storm surge that directly hit the

[Around 237 families benefit this flood control structure especially during calamities. Aside from that, it also protects government facilities such as covered court, barangay hall, health center, school buildings and other public structures," said Caadan.

He also expressed his gratitude to the government for the realization of the project and requested more infrastructure projects for

his constituents.

TACLOBAN CITY -A multi-purpose building worth P4.92 million is soon to be finished which will serve as a venue of different community occasions in Barangay 4, Jaro in Leyte.

Engineer Leo Edward Oppura, chief of the Leyte Second District Engineering Office (2nd LSDEO) of the Department of Public Works and Highways (DPWH), said that the construction of the said facility will be completed by June 21 of this year.

"The infrastructure is designed to provide the

entire local community with space for a variety of activities and services," he

DPWH-8 acquires 14 brand new heavy equipment

BARAS, Palo, Leyte-Fourteen brand new heavy equipment worth P99.5 million have been procured by the Department of Public Works and Highways - Regional Office 8 (DPWH-8) for the usage of 10 district engineering offices in the region.

Equipment Management Division (EMD) Chief Alex S. Dagalea stated in his report to Regional Director Allan S. Borromeo that 14 units of equipment have been acquired by the office through regular bidding.

"These will be deployed to various DEOs that critically need equipment especially during disasters," Engr. Dagalea said.

Among the newly-procured equipment are four units of hydraulic excavators (backhoe), seven units of backhoe/loader, one unit of road grader, a payloader and a drop side truck with 3T crane capacity.

Borromeo said that he

observed that with the two recent typhoons that hit the country citing "Agaton" and "Odette," Eastern Visayas has suffered immense damage, mostly areas within the jurisdiction of DEOs.

"Undeniably, so much has changed on how typhoons and other natural disasters affect our region. The procurement of these equipment will be helpful for DEOs to respond easier and faster during calamities," Borromeo explained.

Out of these 14 equipment, four hydraulic excavators have recently been delivered to DPWH 8-EMD office, and seven backhoe/ loader will be delivered in June. The rest of the equipment are expected to arrive within the next three

Meanwhile, brand new dredging equipment worth P70 million have also been acquired which will be up for use in the Regional Office. These include a swampy tractor, crawler mounted (bulldozer swampy type) and a multi-purpose amphibious dredge. Said equipment are expected to be delivered also in June.

In 2020, equipment worth P134 million in total have also been purchased by the office which are intended for road construction and waste management. These include a rough terrain crane, a self-loading truck with boom, two units of hydraulic excavator, two units of loader excavator, a payloader and one amphibious excavator.

For CY 2019, DPWH 8 was also able to purchase P126 million worth of water-based and dredging support equipment such as amphibious excavators, one payloader, hydraulic excavators, vacuum sewer jet machine trailer, aerial manlift platform truck, among others.

petrated by a group of rebels led by Juanito Sellesa who is known also by his alias 'Ka Tibor.'

Col. Noel Vestuir, the commanding officer of the 802nd Infantry Brigade which is based in Ormoc City, Leyte, said that he welcomes the probe of the CHR involving the killing by the rebels of a civilian saying it was a clear violation of the international humanitarian law (IHL).

"The promotion, adherence, and respect of human rights is the utmost responsibility of every soldier. Thus, assisting the CHR in the implementation of the provisions of IHL and RA 9851 is a sworn duty of individual soldiers so as to protect the life and properties of civilians from a terrorist act of the Communist Party of the Philippines-New People's Army—National Democratic Front," he said in a statement.

RA 9851 penalizes crimes against IHL and other crimes against humanity.

The CHR team, led by Raquel Barastas, said that aside from providing financial assistance, they want that justice will be served to the family and prosecute those behind his killing.

Government forces in the past have criticized the CHR for not conducting its own investigation on atrocities reportedly committed by the insurgents.

Vestuir had earlier said that he is serious in quelling the insurgency problem in Leyte as he called on the civilians to help them by not allowing themselves to be used by the rebels.

TACLOBAN CITY -The Philippine Statistics Authority (PSA) 8 (Eastern Visayas) is stepping up its campaign for the Philippine Identification System (PhilSys) as about 784,142 residents of the region have failed to show up in registration centers.

The PSA has been coordinating with local government officials and conducting mobile registration to encourage the remaining unregistered residents to sign up for the identification (ID) system, PSA-8 Director Wilma Perante said in a phone interview on Wednesday.

Of the 784,142 unregistered, 231,681 are in Leyte province, 172,765 in Northern Samar, 122,945 in Eastern Samar, 122,478 in Samar, 96,623 in Southern Leyte, and 37,650 in

Out of the region's more

than four million residents who are five years old and above, about 3.24 million have completed the twostep registration process as of May 28.

At least 621,685 printed ID cards have been delivered across the region.

Signed into law by President Rodrigo Duterte in August 2018, Republic Act 11055, or the PhilSys Act, aims to establish a single national ID for all Filipinos and resident aliens.

The national ID shall be a valid proof of identity that shall be a means of simplifying public and private transactions, enrolment in schools, and the opening of


